SSBRA business -

- Financial Report Bruce Ashton
 - BA reviewed the latest financial reports for the association and reminded the members that they can always review the reports on the website on the member's page.
- BA also reminded the members that the 2016-2017 dues are due and they will be past due as of 7/1/2016.
- MH reminded the members that everyone needs to submit a returning member application for the 2016-2017 season. MH said 85% of the RMAs have been submitted already.
- MH asked the members to make sure they have their picture posted in Arbiter on the profile page. 40% for the members still need to post their picture.
- MH reminded all members about the 5 required Cal South Training per year and the 5 required SSBRA General Membership meetings per membership year.
 - MH talked about the SSBRA sponsored Referee Professional Development Training and that SSBRA has now hosted 18 RPDs over the last 2 years with over 500 RDPs attendees.



- League status MH covered the following information about the different leagues we serve.
 - BH 7v7 We had a great season and the customer was very happy.
 - LA Riot We had a great season and the customer was very happy. In fact they asked us to support a set of four off season matches.
 - Lawndale Great Season but we had some issues and the Board is working with Lawndale on an issue resolution process for next season
 - DirectKix 6v6 soccer Fairfax High School so far so good.
 - MB 7v7 No issues and the seasons continue throughout the year.
 - Friendlies ongoing
- 2016 Recertification MH reported that 137 out of the 158 members have recertified for 2016. The remaining 21 need to certify for 2017 in order to get assignments from SSBRA.
- Board members speak
 - VP SM provided an update on rankings process, he is setting up the rankings committee meetings and he hopes to be done this month.
 - Assignor
 - VA provided an up and on the upcoming tournaments with a strong emphasis on availability for Galaxy
 - VA talked about the continued issues with turn backs. VA said the she is fighting a 25% turn back issue. VA asked for ideas and suggestions from the members. Some suggestions from the members s included;
 - Drop the rankings of the members who turn back assignments.
 - Drop the member to the bottom of the assigning list.
 - Charge a turn back fee of \$3 or \$5.
 - Don't assign members who turn back assignments until all other members are assigned.

VA thanked the members for the suggestions and said we had to find a solution. No decisions were made during the discussion.

- Assessments DM told the members that he will work with them on assessments and assessments can be used to adjust rankings.
- Member At Large CN encouraged everyone to take advantage of the training resource that the SSBRA hosted RPDs provides to all members. The more attendees the better.
- Finance BA had no additional information.
