MALLEN AND ZIEGLER REELECTED AT AGM; K-A KAMARA ON HAND FOR AWARD

An unusually well-attended Annual General Meeting reelected by acclamation **Tom Mallen** and **Jon Ziegler** to treasurer and vice president, respectively, for another two years. The group, 50 strong, did not nominate any other candidates to run for the two board offices.

Another item on the agenda, a bylaw change to shave the quorum for meetings by excluding honorary members in the membership count, also passed without opposition. The quorum is 25% of the newly-defined membership total. Also adopted without objection was a change to allow meeting notices to be emailed, saving the cost and work involved in sending out 95 (now 98) notices by snail mail.

Kei-Ansu Kamara, a senior at Leuzinger High School, came to the meeting with his club coach, Bruce Myhre, to receive SSBRA's annual scholarship award for the player exhibiting the best combination of sportsmanship, leadership and soccer skills in games officiated by referees of the association. The award, this year for \$300, will be used, according to the modest, soft-spoken winner, to help pay for a soccer training trip this summer in Europe. He plans to attend Cal State Dominguez Hills in the fall.

[Kei was also named the 2003 Daily Breeze Player of the Year, according to a brief article in that paper published the following day.]

Following the meeting, the group, augmented by a few more late-arriving members, Kei and his coach, and a couple of visitors who were accepted for membership, retired to Round Table Pizza for the traditional post-AGM party.

ALL WENT WELL AT CVSC TOURNAMENT, BUT CALE'S WEDDING IS OFF

Assignor **Bill Cook** reported that the Conejo Valley tournament went well during his absence to attend his son **Cale's** wedding in Norfolk, Virginia.

According to Bill, president **Larry Stern**, who took over assigning cleanup duties while Bill was away, had very few changes to make, as there was only one last-minute cancellation and one unconfirmed assignment, a great improvement over prior experience. Over 40 members participated in the tournament.

For now, he has no more games to assign until August, although he did not rule out last-minute requests for officiating help from tournament organizers in the area. Stay tuned.

As for son Cale's wedding plans, the couple agreed to call it off at the last minute, and he has left the Navy and will start looking for a job. In the meantime, he might be available for some refereeing assignments.

TREASURER'S REPORT

Tom Mallen reported that the treasury is down to \$833 and change [how will he pay for all that pizza and beer?]. He made a plea for anyone holding game fee checks made out on the old account at Washington Mutual to cash them immediately, since the account will close very shortly after 1 June. The new account at TRW Credit Union (soon to change its name) is fully operational.

Tom also reminded the group that 2003-2004 dues will be subtracted from any tournament fees owed by those who officiated recently, unless he is informed otherwise by someone not wishing to retain membership in SSBRA.

FROM THE SECRETARY

According to secretary **Dick Eastman**, the Guide to SSBRA was recently distributed to all members with e-mail addresses. Hard copies will be mailed to those not on line.

There is one minor error in the Guide: the Redondo Employees' Lounge is reached from the *southeast* corner of the Carnelian/Broadway parking lot, not the southwest corner. The error did not appear to have hampered the AGM turnout, which was more than twice the required quorum. [The lure of pizza? Or as Homer Simpson would say, pizzaaaaa.]
