### MEMBERS RATIFY BOARD AFTER BEING PAID OFF BILL SHARES HIS OPINION OF SSBRA TOURNAMENT PERFORMANCE WIFE-CARRYING AND GEEZER-CARTING ALTERNATIVE REVEALED

As is becoming a habit, Secretary **Warren Howell** took the floor at the opening of the abbreviated August meeting (held in the cafeteria), and was able to persuade a few new-comers to stand up and introduced themselves, though most of these decided to lay low rather than risk public embarrassment. Doing double duty in the absence of Treasurer **Steve Brandon**, Warren passed out a financial report, that revealed we have \$7298.99 in the bank and a lot of other details that he was not familiar with, nor that anyone else expressed interest in. Warren then mumbled something about the audit of USSF 2008 certified Members, payment status of said Members (106 out of 197 had paid), and told us that he would be pursuing the unpaid and undecided in order to get the roster up to date and the dues settled.

Tired of hearing Warren's voice, President **Ed McClure** took over the meeting, and, per the newly revised bylaws, asked for ratification from the gathering of appointed Board Members **Bill Cook**, **Gabriel Goldsman**, **Lee Jordan** and **Heidi Garlick**. The Members present were more than willing to do this, and there were no objections offered as the group was ratified by acclamation. While all this dreariness was going on, a far more interesting activity was taking place, as **Surendra Menon** and **Bill Mindlin** had volunteered (more or less) to hand out an astonishingly

large pile of checks (some of these were reduced by the amount of the yearly dues), which they did for most of the evening to those present.

Ed wasn't done talking yet though, and told us that contracts for SBS, SBPSL and the J-League were in the works, with SSBRA trying to get raises for the Members where it could (PSL had agreed to go with the same rates as CSL). Ed also said that there was talk of SSBRA getting more premier games, though that was still to be decided.

Having tired somewhat, Ed then turned things over to Assignor Bill Cook, who told us that about \$23,000 had been invoiced for our work in the August tournaments. Last week-end we covered 11 fields with 204 games, which was unprecedented (see kudos below), even though in total there were less pre-season games this year than in years past. Bill then explained that he would attend the CSL meeting the following evening, at which the fields we would be responsible for would be determined and the handbooks passed out (see him for your copy, or come to a meeting). Somehow all of this inspired **Alex Mebene** to ask to speak. This he did, telling us about some educational DVD's he was selling about the Laws of the Game and such – see him if you are interested.

That was not the end of the interesting information on this night by a long-shot, as **Manny Fineberg** got up to speak and told us about the great shirts (and great prices) that he could offer SSBRA Members through soccerone.com (look for the link also on SSBRA.org). One can get just about everything else you might need there too, including shorts, socks, whistles, game wallets, and so on, even 2-way radio sets, all of which are available through the VIP program (free for SSBRA Members to join) at discount prices for even more savings.

Having rested up a bit, Ed took back the floor and started talking again, mentioning that the Welcome Wagon and Mentoring program were going to be discontinued, and the Sportsmanship award was going to be re-worked. A discussion followed these announcements, with **Rudy Chavez, Veto Galati, Harry Ross** and **Larry Stern**, among others, sharing their views, and **Jim Lucania** telling us that the State mentoring program is now being run by **Larry Yee** and that anyone interested could contact Jim directly for more information.

Ed reminded us that we should make an extra effort to come to the September meeting, as the Cal South folks would be coming out again to help get us USSF registered for 2009. He then closed the formal meeting, and everyone started doing what they like best, talking with and enjoying the company of their fellow referees in a friendly social environment.

### **Taking Back a Card** (submitted by **Alfred Kleinaitis**, Manager of Referee Development/Education)

A EURO 2008 quarterfinal match between Russia and The Netherlands (June 21, 2008) was the occasion for a referee action which many misunderstood. In the 91st minute (added time), the referee apparently whistled play stopped for a challenge by Russian player #8 (**Kolodin**) against Netherlands player #10 (**Sneijder**). Kolodin was cautioned and then, because he had been cautioned already earlier in the match, Kolodin was shown a red card.

Before the restart for the apparent foul, however, and following an exchange of information between the referee and the lead assistant referee, the second caution and the accompanying red card were rescinded and play was restarted with a goal kick. The issue was widely debated as to whether the referee could take this action in view of the fact that both cards had been displayed.

The referee's actions were within the Law. Based on information provided by the assistant referee whose position provided a better angle of view, the referee accepted two facts:

- The challenge by Kolodin to which the referee reacted occurred after the ball had left the field of play.
- The tackle by Kolodin actually occurred several feet away from the Netherlands attacker, who then tumbled over the defender's body.

From this information, the referee therefore correctly concluded that:

- the challenge (regardless of its nature) occurred when the ball was out of play and therefore the restart had to be a goal kick, and
- the challenge itself was either entirely fair or at least did not rise to the level of misconduct so the yellow card was not justified (with the consequence that the red card also was not justified).

Prior to play restarting following the display of a card, the referee can revise his decision about what he observed on the field, re-evaluate the significance of the player action, or receive additional relevant information from another official (either or both assistant referees or the fourth official). As a result of this further reflection or assistance from other members of the officiating team, the referee can:

- rescind the card entirely,
- decide that the card should be given to a different player,
- display a card to additional players,
- or display a different color card in place of the one originally shown.

As a practical matter, it must be emphasized that the occasion for such an action should be infrequent, that the need to rescind a card is reduced by having as much information as possible before displaying a card, and that referees should not be seen as acting in response to player appeals. If play has been properly restarted, any cards shown must be reported.

### **Finland Holds Swamp Soccer World Cup** (submitted by W. Howell)

July 21, 2008 (Reuters: **Bob Strong**)

With mud up to her waist and the yellow wig hanging sideways, swamp-soccer veteran **Tuula Brocke** reached for the ball just barely a metre in front of her, but her foot would not move an inch. Playing ball in a swamp is like a slow-motion movie coming to a halt every time a player sinks in a hole, she said. "Your opponent snatches the ball right in front of your nose, but you are stuck in the mass of dung and cannot move at all," she said, while wiping dried crust of her arms and face.

Ms Brocke's team, the G-Spots, is one of 340 which competed in this year's Swamp Soccer World Championships, held in northern Finland for the 10th time in a row. Latvia, Lithuania, Norway and Russia were among the growing number of foreign teams. Organisers estimate some 10,000 people attended the event each of the three days.

A natural swamp outside the town of Hyrynsalmi Finland was converted into 22 playing fields marked with yellow tape, more resembling pig pens than a world cup site. There was no offside, no definite penalty box and unlimited substitutions were made on the fly. Even so, each team looked for their own tactic to bring the ball forward in this chaotic and largely uncontrolled game. "We have been training how to walk in the swamp on our fours and to kick from the side, that's the only way we could move it, when the ground got this soft," Ms Brocke said, adding it was guts and always a bit of luck that decided the better team.

The sport was conceived by Finnish cross-country skiers looking for a way to train during the snowless summer months. Portuguese Olympic cross-country skier **Danny Silva** joined one of the teams looking for exactly that kind of exercise. "You can't run normally, and the swamp makes your legs very heavy, that boosts your heart rate and it pumps your upper leg strength," he said, adding it was the Finnish training methodology that was the best part of it all. "Athletes get way too serious when they train, this is bizarre, but makes training so much more fun."

Shoes and socks were taped with duct tape. Supermen outfits, wigs and men in dresses were common, as were men dragging women through mud and the latter kicking back twice as hard. The swamp is much cleaner now than when it was still full of tree stumps and branches a decade ago, one player said. But bruises, cuts and strained muscles are always part of it all, especially when extreme fatigue sets in after playing several games in a row. Not drinking water from the swamp and insurance protection were rules organisers emphasized most.

For most of the team the weekend-long event was a fun mud bonanza for as long as the midnight sun shone. Winning the trophy in the men's, women's, mixed or hobby category was secondary, at least for most....

After a while the SSBRA spectator refs left, and the game ended without any other unusual incidents. The team that had been cheering for Bluto all along continued to show their approval and support for his efforts after the game too, even though they lost anyway.
