NOMINATIONS, COMMAND PRESENCE, AND SOME KEY REMINDERS!

GENERAL MEETING: APRIL 27, 2010

Warren began the meeting by reassuring us that Ed Beverly's wife's – our beloved "Orange Lady" – surgery went well and that she is recovering well. He then turned the floor over to Manny who was running a special on his devastator whistles: 2 for \$15. He also graciously donated a set of flags for our raffle.

Warren then reminded us that May is election month and that the general meeting for May will take place at the pizza place (location to be emailed out in May) at 7:00pm, rather than our usual 7:30 p.m. (Note the time change: May's Meeting is at 7:00 p.m.) And, although Steve would be running the nominations portion of the meeting, Steve was still handing out his makeshift raffle tickets at this point so Warren announced the positions that will be up for election in May. They are as follows:

- o President
- Secretary
- o Member at Large
- Vice President (note this will be a 1 year term because Gabriel is resigning so his successor will serve the remainder of the two year term)

Warren and Larry then clarified that bylaw changes do not have to be submitted ahead of time.

Warren then inquired as to whether any of our members were still experiencing email problems. Lee – our webmaster – then clarified that most of the current email problems are with AOL users. Apparently, if one AOL users marks a SSBRA email as spam, AOL will automatically recognize a SSBRA email as spam. So, if you are having email problems you might have to change your settings so that the SSBRA emails don't go to your spam folder.

Our new members and first timers then introduced themselves. Included were Anthony Bauwens; John Hough; Eric Bails; Silvia Flint; Kyle Wilkinson; Hector Renza; and Mark Feves.

Someone – I believe it was Warren – then praised Bill on his organization, noting that he realized that SSBRA is a whole lot more organized then some other associations at one of the recent nationals where referees from other associations didn't know what field they were on, how many games hey were reffing, or even who they were reffing with.

Warren then noted that we are doing better at showing up on time – or calling Bill and/or our partners if we're going to be late – but we could always get better. He reminded us that it is not an excuse, or justification, that the teams show up late, or that the fields are not set up. The teams showing up on time, and the fields being set up on time are not our responsibility and we can't control those. However, we can, and should, control our own timeliness. And, regardless of the teams and the fields, it's our responsibility to be there on time. So, let's stay profession and show up on time.

Warren also noted that we need to show up in the proper uniform, with proper equipment. Manny is at every one of our meetings so we really have no excuse not to show up in dressed properly. Further, make sure you know the rules of the league you are reffing in. Remember, you are a reflection of SSBRA as an association and, if we want to keep getting games, we've got to be professional. Professionalism at the very least means you show up on time in a proper uniform, with the right equipment, and you know the right rules.

Warren then informed us that he has been discussing our contract with South Bay Sports (our Aviation and Crossroads games) and that, at this time, SBS is not willing to give us a raise. In fact, SBS informed us that they cannot give us a raise and, if we insist on a raise, they may have to just use their staff to ref, rather than SSBRA. Based on this position, the board felt it was only appropriate to get ask the members what they would like: move forward with negotiations or retain the current rate. Those present noted that they were fine with retaining the current rate/fees as they are. Therefore, the board will not pursue an increase in referee fees with SBS at this time.

In light of the fact that we are not pursuing a raise in fees at this point, some members did inquire whether SBS will consider discounting the registration fee of the referee teams that actually play in the league.

Then some members voiced concerns about the administrative side of things at SBS, specifically:

- Players not having any numbers: the members expressed that they've raised concerns about this before but its still not getting better
- Taking too long to check in teams and there is not enough time in b/t games to check them in
- Field marshals are not available either they are not there at all or cant be found or they are there but playing so they are not available

Warren let members know that we're preparing a letter to send to SBS about this.

Rudy also visited briefly. Unfortunately, he didn't stick around for us to all say hi. But, he's looking better! ©

Then it was time for nominations. Steve ran this portion of the meeting. The nominations are as follows:

Note: there will also be space on the ballots for write-in candidates.

After running the nominations, Steve gave his treasurer's report. He had emailed all of us his report, so there wasn't much to say. Feel free to email Steve if you have questions. He also said he's working on the Manhattan Beach/Village checks.

Larry had nothing to report so Bill took over. He noted that he has CSL books still if anyone needs them. He then said that there is not a lot going on right now, Spring League ended the last weekend of April, and Spring Cup would be starting the first week of May. Bill noted that the game fees and game lengths in Spring Cup are different so know them if you do a Spring Cup game. Bill also told us that the Seal Beach tournament would be the first week of May and that we have six fields for that tournament, which means he'll probably need 12 refs on both Saturday and Sunday. Bill then said that summer tournaments will start soon and that he'll contact the Valley and Orange County groups to see whether they will need us for their tournaments. Bill capped off by thanking all the referees who did the National Cup games and said that we got really good games this year.

Vince then took over and asked that all new members see him for rosters and patches. He then told us that we should have our 2010 grade 8 patches from Cal South too. But, if you are something other than a grade 8, let Vince know because there is someone else he has to contact to get those. He also noted that some people are not registered with Cal South so they won't get their patches until they do.

He then said don't put your social security numbers on the reports you send to him. Also, don't send your reports to the league first. Send your reports to Vince first so he can make sure it makes sense.

Finally, Vince echoed what Warren said: know the rules of the league you are reffing in and be on time and make sure you are dressed properly when you show up to ref. This means:

- o Black shorts (at SBS, if you are going to wear sweat pants, make sure they're black)
- Black socks
- o Black shoes
- o Ref Jersey
- o Whistle
- o Watch


Vince then told us that the leagues have been pretty good in following up with us and supporting us with regard to players that have threatened referees

Bill then remembered one more thing he wanted to say. He told us that we had 18 refs at the J-League tournament and that J-League will be mailing a check out at the end of April. So those who reffed the J-League tournament can expect to receive their checks in early May.

The Cal South presenter – Toros Kibritjian – then took over to teach us about Command Presence Through Words.

The objectives of this presentation were to learn the following: the benefit of command presence is respect for the referees; there are three ways to improve and establish command presence; and there was a third objective but I didn't get it.

Before diving into command presence, Toros reviewed last month's presentation on Game Management, reminding us that the referee has discretion to handle problems, the referee's personality is important, and that player management is important. Here's the Game Management Model from March 2010.



After the review of March 2010 Game Management Model, we dove into Command Presence with a few MLS Clips. "Aura" was the word of the day. Command Presence, we were told, is all about our "Aura."

Merriam Webster's online dictionary defines Aura as: "a distinctive atmosphere surrounding a given source for example: "the place had an aura of mystery"). Dictionary.com defines "aura" as: a distinctive and pervasive quality or character; air; atmosphere: an aura of respectability; an aura of friendliness;" and "a subtly pervasive quality or atmosphere seen as emanating from a person, place, or thing. Synonyms for aura include: air, atmosphere, feeling, impression, sensation, characteristic, quality, appearance. A good aura (and/or good presence) will result in respect from the players.

Your presence as a referee is important. It is established the second you walk onto the field: your uniform makes the first impression (hence the stress on dressing properly). It is further established by your first foul – the way you blow the whistle communicates a certain presence and/or confidence (or lack thereof). One way to control the game and establish your presence is by talking to the players.

There are three ways to send messages:

- o Para-verbal: Talking and acting at the same time 38%
- o Verbal message 7%
- o Non-verbal message 55%

Para-verbal message are how you say something. How you say something is very important. Consider your:

- o Tone
 - How you say it
 - Inflection
 - Light hearted/stern
 - Cadence (speed) of speech
- o Volume
 - Make sure its appropriate for the message you are trying to get across appropriate for the desired effect
 - Calmness evokes control


You should act, not react. For example, when a player disrespects you as a referee, talk to that player, maybe issue caution if its warranted. Send clear, consistent messages. For example, Toros showed a clip of a slide tackle to leg where the referee went straight to the spot of the foul to stop any potential conflict and addressed the player who committed the foul.

You have to show the players respect too. When issuing a card, tell player why and let everyone see that you are talking to the player. Important, keep a smile on your face. Remember, you are sending a message, don't send the wrong one.

Keep in mind that conflict and stress inhibit communication. Usually, less talking is more powerful but when you do talk, be loud and clear. BUT, don't take longer than 5-7 seconds when talking to a player (don't be like that referee in that clip that just kept talking and talking and talking). Remember, the Referee that is in command won't lose his self composure.

A point to take away: be calm and show respect. Talk calmly to players and coaches, with a smile on your face if possible.

Toros then introduced the following "step approach to messages."



Watch out for escalation in the last few minutes of the game. Don't threaten a player with dismissal because then you have to carry out that threat. "Warn" – give yellow card if and/or when game needs it, but first think twice about whether a warning will suffice.

Toros made a distinction between Listening and Hearing. He noted that gearing is not listening: it's dismissive; it's "in one ear and out the other." You may have to concentrate on the player that is simply hearing and not listening to you.

Some Concepts to remember:

- o Broadcast your message in the first 5 min
- o 1st time you blow the whistle for a foul, blow it with confidence
- o Don't be afraid
 - According to Toros: any ref afraid to give a penalty kick shouldn't be a ref. A ref needs courage to make a pk call.
- Work together and Protect each other: Refs protect your ARs; ARs protect your refs
 - Pregame discuss signals for caution and send off advice
 - Create "family" and/or "team" feeling
 - Anticipate confrontation
 - Don't insult your AR's, use your AR's
- How you say something is very important
 - Tone
 - Volume
 - Calmness evokes control
- Show players respect: Maybe talk to them first before issuing a caution
- Respect coaches too smile at them

- O Don't get angry and favor one team over the other (i.e. don't favor the team that is not complaining).
- o Pick your battles
- Dealing with dissent
 - Create distance from dissenter
 - "draw a line in the sand"
 - Staying may encourage or invite more dissent
- Yellow card
 - Isolate the player
 - Don't show a card to a player's back
 - Record the cards
 - Record #, time given, which ½ (or which ½ of OT if applicable)
- Feedback after listening
 - Listen to what the player is complaining about
 - Compliment
 - Present facts: talk to, not down to
 - Encouragement may lead to a positive outlook
 - Follow up later
- o If players fall, do not assist them, just call the coach out to handle it

A note on fouls: Just because got the player got the ball doesn't mean its not a foul. You cannot make contact with a player's leg and make him fall, even if you get the ball.

Clouds across the Toon

Full 90s? How about a full 35 (hours that is)? Teams battle to break record for longest ever football match... and the final score was 333-293

Just before kicking off the record attempt, last chance for second thoughts. The charity match was played Friday 30th April - Sunday 2nd May and kicked off at 6:00pm

Ninety minutes is a lovely amount of time for a match. Two 45-minute halves of continuous play split up by a 15-minute break and you're back out the gate in less than two hours. But when you're attempting to break the Guinness World Record for the longest match -- which stood at 33 hours -- to benefit charity, as Cambray FC did in Cheltenham, England last weekend, the rules are a bit different. Namely, they go like this (as explained by Cambray):

- -Players not playing for either team must remain by the pitch side and not leave the area throughout the game. For example those off for a while to rest/sleep must do this pitchside.
- -Only 18 players are allowed in each squad. Basically we have to cover the normal rules of a football match throughout the whole game.
- -A 5-minute break is earned for each hour played. Breaks can be accumulated, e.g after 4 hours continuous play; a 20-minute break can be had.
- -An official break is the only time a player can leave the pitch or pitchside area.

So at 6 p.m. local time last Friday evening, Cambray FC lined up against a team comprised of their own local Cotswold Churches League All Stars on a pitch surrounded by tents for the 36 players and whoever they could convince to come and watch as they attempted to play for more than 40 hours straight.





Through the night and into a sunny Saturday that turned to "torrential rain" that hammered down for 15 hours non-stop, soaking the players and making a mud pit of the pitch, the match went on, finally ending at a record 35 hours after a vote among the players during an official break because playing conditions were no longer safe. Final score? Cambray 293, All Stars 333.

Said one of the players' wives:

"Supporters have been coming through the night to watch them and have even pitched up their tents as well.

"The players are completely shattered and many of them have been left with injuries.

"We had to make the decision to stop when the rain got heavier and it became a bit too dangerous."

In the end, Cambray not only broke the record and proved that the sport isn't at all low scoring when you play for 35 straight hours, but also reached its goal of raising £30,000 (about \$45,000) to build and equip a school for the Dalit community in India. Then they all went home and probably vowed to just have a bake sale next time.

A Tragic Story: Croatian soccer player Goran Tunjic gets yellow card for diving as he dies of heart attack on field

A 32-year-old Croatian soccer player may be the first to receive a yellow card while dying on the field. <u>Goran Tunjic</u>, a defender for Mladost in <u>Croatia</u>'s fifth division, suddenly fell to the field and died of a heart attack during the first half of a match against Hrvatski Sokola, according to the Daily Mail.

Thinking Tunjic was taking a dive, the referee made his way across the field to book him, holding a yellow card in the air. The Daily Mail reports the official had warned both teams before the game that he would be very tough on players embellishing injuries.

Sokola's fans cheered after the booking, but as the referee and players surrounded Tunjic, they realized something was wrong. The referee then called for medical help. "Doctors tried to help him, but there was nothing they could do. He just fell dead on the spot," a Mladost spokesman said.

Tunjic was declared dead on arrival at the hospital. He reportedly had no previous health problems. The 0-0 game was called after the incident.


