#### BOARD MEETING: MAY 18, 2011

- I was unable to make the May 18, 2011 Board meeting so Steve kindly took notes.
- Treasurer pmt error for Manhattan Beach discussed and addressed
- 4 applications accepted
- Bad boys and girls discussed and solutions determined
- Discussed game management skills for younger referees
- Discussed follow up with SBS game incident
  - o Bill talked with Dennis and noted we deal with fouls AFTER they have been committed
- Talked about referees who get game assignments then turn them back; Bill drops them to bottom of assignment list
- Received complaint that SSBRA web site does not show single game call in requirements. Noted this is mentioned at every monthly meeting and in the FW
- Assignment system seems to be working correctly for last two weeks.
  - Assignment problems seems to be due to memory problems and needs upgrades.

## Mexico blames tainted meat after soccer players fail dope test

CHARLOTTE, North Carolina (Reuters) – Five Mexico players suspended from the Concacaf Gold Cup after failing a doping test had eaten contaminated meat and should be cleared after a second test, a Mexican soccer official said.

The Mexican Football Federation on Thursday said the players had all tested positive for the banned substance clenbuterol from tests carried out in Mexico on May 21.

Clenbuterol can be used to speed up and increase muscle mass in animals. A number of athletes, including three-time Tour de France champion Alberto Contador, have blamed their positive test results on eating meat adulterated with the steroid.

Hector Gonzalez, Femexfut's director of national teams, said the players had eaten tainted meat at Mexico's High Performance Center where the team prepared to defend the Gold Cup.

"Unfortunately, by accident, these players are beef contaminated with the substance clenbuterol," he told a news conference following Mexico's 5-0 win over Cuba in Group A.

Gonzalez said Mexican farming officials were looking into beef supplies at the center.

"We're confident that with the investigation that is being carried out we'll be able to clarify (the situation) and reach a happy conclusion," he added.

Femexfut general secretary Decio de Maria earlier named the players as goalkeeper Guillermo Ochoa, defenders Francisco Rodriguez and Edgar Duenas, and midfielders Antonio Naelson 'Sinha' and Christian Bermudez.

De Maria said the players, who face bans of up to two years, had all been suspended from the tournament.

Gonzalez said the players would fly to Los Angeles on Friday for another test at the University of California Los Angeles's certified laboratory which would "surely be negative."

"We will ask also for the B samples (of the original tests) to be opened and we will await the results," he added.

Mexico had only 17 players available for their match against Cuba, their second successive 5-0 victory that qualified them for the quarter-finals. Defender Ricardo Osorio left for home earlier in the week due to illness.

Gonzalez said Mexico had appealed to be allowed to call up five replacements, a request that would be dealt with by the organizers at a meeting on Friday.

He added that tournament rules stated the team could not be docked the points of their win against El Salvador on Sunday because the results of the doping tests were unknown when the match was played.

El Salvador's Uruguayan coach Ruben Israel said he hoped the Mexicans had not obtained Sunday's victory through cheating and he did not want to make a premature judgment.

"It's a tremendously delicate matter that touches the morals of the (Mexican) players and national team," Israel said after his team's 1-1 draw with Costa Rica in an earlier Group A match.

"I'm sure my (Salvadorean) federation will come down with all their might on this issue if it's confirmed (that Mexico faced us with doped players)," he said.

De Maria earlier said there was a health alert in Mexico because of food contaminated with clenbuterol.

Mexico denied in April that its beef contained clenbuterol days after Germany's anti-doping agency advised athletes not to eat products from Mexico because it might increase the risk of involuntary positive doping results.

## You've become a good ref when ...

You will know that you have become a good referee when:

- After the game, players and coaches go out of their way to say "Good job," "Great job!" or "You were the best ref we've had all season!"
- People say to you, "Could you officiate all our games?"
- Your phone and e-mail account become hot with more and more assignments.
- You are assigned top games.
- You are asked to officiate tournaments out-of-state and maybe even abroad.
- You receive officiating awards from leagues and referee associations.

This means you have succeeded. Congratulations!

Now you come to an important fork in the road. Or as Yogi Berra has said, "When you come to the fork in the road, take it!"

Some successful referees take the correct road. They know that they have succeeded because of their knowledge of the Laws of the Game and their application, their hustle, their positive attitude, their fairness and firmness plus their approachability. And they continue doing all these great things.

Other successful refs take the wrong road. Their success goes to their head and they somehow think the game is now about them.

I have heard these comments about refs:

- "He used to be really good and now all he wants to do is argue with the coaches."
- "He was one of our top referees but he no longer runs and gives decisions that seem solely to create attention for himself."
- "He's a good ref. The problem is, he thinks that he is a great ref and lets everyone know it."
- "She was a very good referee. Now people don't take her seriously as her body has become as big as a house."
- "He was one of our best referees. Now he hardly moves out of the kickoff circle."

Which road are you going to take?

## Referees unconsciously favor teams in red uniforms

"A team manager's choice of a red uniform can affect a referee's decision making and benefit the team during a game."

This statement was made by a group of psychologists and teachers at the University of Münster Germany.

Norbert Hageman, Bernd Strauss and Jan Leibing, conducted the study which was published in the journal Psychological Science.

#### Penalized fouls compared in video

Although the initial experiment was conducted with judges from taekwondo, the researchers then tested referees in other sports where the competing teams wore red shirts and other colors.

In the study, officials viewing the match in a video must punished the fouls committed from both sides in the first half of the match.

They were then shown the same video a second time but with the uniform colors reversed, using a video trick.

#### Red is favored

According to the researchers there was an increase of 13% in foul calls compared to the average for the first time They noted that decisions of the referee's favored a red uniform when the teams were on an even competitive level, but had little influence when a team was clearly superior.

#### **Research continues**

Although further research is needed, especially on the effects of color, "results in the study conclude with recommending a change in the rules or where the officials utilize "electronic technology" where the color of the uniform may not be a problem."

Next time you're watching a game where one of the teams is wearing red, pay attention and find out if this study is true or not.
