# BOARD TAKES A STAND ON SEXUAL HARASSMENT AND CONCUSSIONS ELECTIONS ARE HELD AND BYLAWS ARE CHANGED A MEMBER MAKES A DECISION

For some reason the Annual General Meeting was once again held in a back parking lot of Lamppost Pizza, and a quorum of Members was seen hanging around suspiciously, waiting for the proceedings to begin. Warren 'Bluto' Howell was up to the task, and started in talking about the topics du jour. He informed all that, because of new insurance requirements, SSBRA had to come up with formal policies about player concussions (no play, no way, for those who get them) and sexual harassment. This is now explained on the web-site, and all Members are expected to look it all over and understand it. A game request form was also added to ssbra.org so that those requesting referees for "friendlies" and possibly other matches could provide the needed information. Responding to a question from Dan Ayala, Michael 'Waki Mike' Hinz told us about the business cards SSBRA is developing - these could be passed out to coaches etc. at venues and provide contact information for SSBRA. It was then explained that the Board had recently once again taken a look at using Google-wallet, Pay Pal etc. technology as a replacement to paying the

Members by check, and had again rejected the idea because of the cost and extra work involved.

There were then short speeches by the rest of the Board: Michael Hinz enlightened on several subjects, Chris 'Not-So-Large-Member' Nevil told us about the good stuff going on at RPD, Bill 'Robocop' Cook praised our efforts at the recent tournaments, Veto 'Jersey Boy' Galati was too busy getting ballots ready to say much, and Ralph 'Worst-Ref-In-Town' Quiroz declined to speak.

Veto then ran the election (with a small assist from Warren), with the following results:

- President: Michael Hinz

- Member-at-Large: Chris Nevil

- Secretary: Veto Galati

The bylaw amendments were then voted on, with the measure about attending 5 meeting a year being defeated, while the rest were passed. There being nothing more to say, everyone moved into the restaurant for pizza, adult beverages, non-adult beverages, and a lot of carrying-on, the details of what happened in Torrance having to stay in Torrance.




# Can't We All Just Get Along? (Recent news article)

Prakong, covered in bruises, insisted that he had refereed the game fairly, and had been asked by his soccer federation to press charges against his attackers in the Kuiburi team.






#### This is Why They Put Numbers on Their Jerseys (Recent news article)






#### **Quiz Answer**
