

## Cal South Training by Randall Reyes:

Randall Reyes conducted the Cal South In-Service Training session regarding feedback on referees from coaches in youth leagues in Cal South.

## President speaks:

MH informed the membership that due to an issue with the CSL rosters, SSBRA was receiving all emails related to referee issues for the first few weeks of the 2017 season even though none of the issues involved SSBRA referees or SSBRA matches. MH told the membership that SSBRA did not receive a single complaint the entire year while other Association's receive multiple complaints on a weekly basis. MH thanked the membership for their professionalism and stated that he felt SSBRA has the best referees around.

#### MB 7v7:

New rules will apply in 2017 for discipline for a yellow card. Starting in 2017, a cautioned player must sit out, with the team playing short, for either 2 minutes or until a goal is scored against the cautioned player's team.

#### Season wrap-up:

VA gave membership a summary of the past season. Total of 1500+ games covered. Friendlies are on the rise as season is ending. VA reminded everyone to keep blocks updated for friendlies opportunities. VA also informed the membership that since the reassigning fee was instituted the rate of turn backs have decreased from 35% to ~10%.
